HOUSE BILL NO. 322

EXPLANATORY NOTE

This bill intends to separate the Lamon Bay School of Fisheries Annex in Barangay Aloneros, Municipality of Guinayangan, Province of Quezon from the Lamon Bay School of Fisheries Main, converting it into an independent National High School to be known as Aloneros National High School.

Lamon Bay School of Fisheries annex started its operation in 1999. Since it started, the operational expenses of the said secondary schools such as salaries of school teachers, school supplies, books and other materials are shouldered by the Sangguniang Barangay of Aloneros and the Municipal Government of Guinayangan.

With the present economic policies of the national government wherein it slashed some financial aids to local government units, funding for educational programs will be a great financial burden for the Sangguniang Barangay of Aloneros and the Municipal Government of Guinayangan. Thus, the educational advancement and the welfare of the teachers as well as the students will be jeopardized.

With the nationalization of the Aloneros National High School as envisioned in the Act, it will be accorded a bigger budget and consequently enable the same to provide better education and upgraded educational facilities.

Early passage of this bill is earnestly sought.

AN ACT SEPARATING THE LAMON BAY SCHOOL OF FISHERIES ANNEX IN BARANGAY ALONEROS, MUNICIPALITY OF GUINAYANGAN, PROVINCE OF QUEZON FROM THE LAMONBAY SCHOOL OF FISHERIES MAIN, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE AS ALONEROS NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. *Separation and conversion into a National High School.* The Lamon Bay School of Fisheries Annex in Barangay Aloneros, Municipality of Guinayangan, Province of Quezon is hereby separated from the Lamon Bay School of Fisheries main and converted into an independent National High School to be known as Aloneros National High School.

SECTION 2. *Transfer of assets and liabilities.* All personnel, assets, liabilities and records of the Lamon Bay School of Fisheries Annex are hereby transferred to and absorbed by the Aloneros National High School.

SECTION 3. *Appropriations.* The Secretary of Education shall immediately include in the Department's program the operationalization of the Aloneros National High School, the funding of which shall be included in the annual General Appropriations Act.

SECTION 4. *Implementation.* The Secretary of Education shall issue such rules and regulations as may be necessary to carry out the purpose of this Act.

SECTION 5. *Effectivity.* This Act shall take effect immediately upon its approval.
